B r i d a l T e a m

1. This agreement constitutes an order for your makeup services and/or hair services, including the taking of portrait photos as agreed to both parties: Chateau Cheveux and contacting party . Unless otherwise specified, it is understood that any and all photographs may be used for advertising, display or any other purpose thought proper by Chateau Cheveux.
2. If the makeup and/or hair artist(s), cannot perform this agreement in whole or in part due to a fire, or
other casualty, acts of God or nature or terror or other cause beyond the control of the parties due to artist's illness or injury, then Chateau Cheveux will return all fees to the Client(s) but shall have no further liability with respect to this agreement.
3. In the event of an extenuating circumstance on Chateau Cheveux's part, Chateau Cheveux will reimburse the full amount paid to the customer, including the deposit or re-schedule for a different time. Chateau Cheveux will not be held liable for services not rendered. To receive refund, Chateau Cheveux must have a 2-week notice from the schedule session.
4. On signing of this agreement by both parties hereto, Chateau Cheveux will reserve the time agreed upon and will not make another reservation for the specific timeframe.
5. Sunday and Monday events will have an additional \$200 charge.
6. The amount agreed upon covers the hair stylist(s)and/or make up artist(s) time and talent. It also cannot be changed or altered by any means.
7. A non refundable retainer of \$120 is due at the time of consultation appointment. This non-refundable retainer applies to bridal parties. This guarantees the time and date allotted for you. Should payment not be received in this time frame, Chateau Cheveux reserves the right to offer the date and time to another client.
8. Chateau Cheveux's price list is adjusted periodically and future orders will be charged at current pricing of that time.
9. The artist's/stylist's name shall be printed in any publication of the photographs. The client shall use their best endeavors to ensure that the artist is given full acknowledgment in any edition of the work sub-licensed by the client to a third party.
10. Client agrees to notify makeup artist of any allergies he/she may have toward any cosmetics of chemicals.
Should a reaction occur, requiring medical attention of not, it is agreed that the makeup artist is not legally liable or responsible for injury and/or ailment of any kind.
11. Cancellations must be made two weeks (14 days) prior to your reserved date or you will be responsible for the amount of services agreed in this contract.
12. There is no travel fee for the first 30 minutes of travel from the salon. Over 30 min-1hour...\$50
1 hour-1.hours...\$100
1.5- 2hours.....\$150
Over 2 hours of travel, fee is at the discretion of the stylist/artist.

BUSINESS POLICIES

Copyright Information: The artist's name shall be printed in any publication of the photographs. The client shall use their best endeavors to ensure that the artist is given full acknowledgment in any edition of the work sub-licensed by the client to a third party. If a photograph is posted on social media, Chateau Cheveux is to be given acknowledgment of the hair and/or makeup provided. The hashtag, #chateaucheveux, should be used along with the artist's social media pages listed below:

Before Your Session: If you are receiving a makeup application, please wash your face thoroughly and come to the session with no makeup on. If you are having hair services, please have clean hair that is fully dried upon arrival. Anyone with wet hair will be charged an additional fee of \$20 for their blow-out before the scheduled hair service.

Bookings; Clients will be given a schedule for the day of services. No changes to the head count are to be made within 2 weeks (14 days) of the scheduled day. Please make sure every person that needs service is listed on the contract. There is an allotted amount of time given for each service for quality. A late fee of \$25 will be charged for every 30 minutes of delay when a client is late for a scheduled time.

Holidays & Weekends: Events that are on Holidays, Sundays, or Mondays will have an additional \$200 charge.

Retainer Policy: For bridal parties, a non-refundable retainer of \$120 is due at the time of consultation. This guarantees the time and date allotted for you. Should the payment not be received at this time, Chateau Cheveux reserves the right to offer the date and time to another client.

Travel Fee: There is a travel fee for anywhere that is over 30 minutes away from the salon (12 Worcester Street West Boylston, MA). Travel over 2 hours away is at the discretion of the stylist/artist.

Payment Options: The final balance is due on the day of the event prior to services. No exceptions. Chateau Cheveux accepts cash, check, and debit/credit card for in-salon services. Checks to be made payable to Chateau Cheveux. For traveling services we accept CASH ONLY. The person(s) responsible for the entire balance of the payment is the person(s) who has signed the booking contract.

Personal Checks: Checks returned by the bank, for any reason, will be charged a \$25 service charge.

Usage: Chateau Cheveux reserves the right to use any photographs taken (professional or behind the scenes) for display, publication, or other purposes.
